2. The above lots will be restricted as reflected in the Prior Declaration for lots designated as Mobile Home Lots.

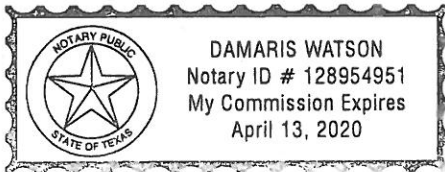




